TERMS & CONDITIONS OF ENTRY

Event Waiver & Acknowledgement

You should read this before completing the rest of the Entry Form. Your registration will NOT be accepted unless the Terms & Conditions/Event Waiver & Acknowledgement are signed as read and accepted.

These Terms & Conditions/Event Waiver & Acknowledgement are designed to enable the 'Gelantipy Wilderness Escape' (the 'Event') on 17th, 18th and 19th April 2009 to run smoothly and safely. By registering to participate in the 'Gelantipy Wilderness Escape', you (the 'Rider') accept and agree to be bound by these Entry Terms.

The Event Organisers/Operators of the 'Gelantipy Wilderness Escape' are The Wilderness Bike Ride Inc ('WBR').

Registration

1. The organisers of the 3-Day Event reserve the right to accept entries at its discretion and also to reject any entries or issue special invitations.
2. Entry is arranged for 1, 2, or 3 days of participation. The Entry Fee is charged per day of participation, and not per ride.
3. Entry forms and payment must be received by Wilderness Bike Ride no later than 5pm on Friday 3 April 2009.
4. All entry forms must be accompanied by the entry fee or by entering VISA or MasterCard details.
5. A contract between the Wilderness Bike Ride Association Inc (WBR) who are the Event organisers and the intended participants shall be deemed to have commenced on the acceptance by WBR of the intended participant's completed application and receipt of payment.
6. There will be no on-the-day registration unless by prior arrangement with the Event Co-ordinator.
7. 1 entry form per participant.
8. This entry form allows for cheque/money order or credit card payment only. Entries can also be made online at: www.wildernessbikeride.com.au.
9. Day Ride pricing is only available to people who are not staying at Karoonda Park, and are only participating for 1 day of the 3 day Event, unless special arrangements are made directly with the Event Coordinator.

Routes/Participation

10. The Rider will elect which route(s) they will participate in. Options available are:
Friday 17th April: Snowy River Gorge and Gelantipy - 40km or 35 km and 16km
Saturday 18th April: Tall Forests - 40km or 56km
Sunday 19th April: Buchan and Snowy Rivers - 25km or 55km
11. The Rider may elect their ride options on a daily basis, and are to attend the muster point for the relevant route at least 20 minutes prior to departure for a briefing. Each rider *must* sign in and out for each ride.
12. It is anticipated that the Rider will have prior experience or be able to maintain a minimum average speed of 14km per hour.
13. Riders under the age of 16 must be accompanied by a responsible parent or guardian on all rides. The details of the Parent/Guardian must be listed on the minor's Entry Form.
14. If the Rider is under the age of 18, the Rider must submit a fully completed entry form signed by their Parent/Guardian. The details of the Parent/Guardian must be listed on the minor's Entry Form.

Karoonda Park Facilities

15. Day Riders do not have access to accommodation, catering or facilities at Karoonda Park as part of their package. Individual arrangements for meals or participation in paid activities provided by Karoonda Park may be arranged by contacting Karoonda Park directly.
16. Participation in additional paid activities provided by Karoonda Park is to be booked with Karoonda Park once you have arrived on site and no later than the night prior to the activity. Payments are to be made directly to Karoonda Park.
17. All rules and requirements stipulated by Karoonda Park are to be strictly adhered to.
18. All enquiries relating to accommodation (including allocation) are to be made to WBR and not directly to Karoonda Park.
19. WBR will endeavour to place you in the most appropriate accommodation based upon availability at the time of you booking. As room changes will not be possible once they have been allocated, please ensure you note all members of your party and any special considerations to facilitate appropriate placement.

Cancellations/Refunds

20. If the Rider wishes to cancel his/her participation in the Event, the Rider must notify Wilderness Bike Ride in writing, providing his/her name address and contact details.

21. Upon completion of this entry registration, AUD \$10 (including GST) of the entry fee is non-refundable up to 5pm on Friday 3rd April 2009; and the total entry fee is non-refundable from 5pm on Friday 3rd April 2009.
22. Entry is arranged for 1, 2, or 3 days of participation. The Entry Fee is charged per day of participation, and not per ride. In the instances where cyclists opt not to participate in an offered ride, no refund is applicable. Where 2 rides occur at the same time, no refund is applicable for the option not taken.

23. Except as otherwise stated in these Entry Terms, Wilderness Bike Ride Association Inc is under no obligation to refund monies or entry fees due to non use, cancellation, failure to participate or dissatisfaction by the Rider.

Transfers

24. The Rider may transfer his/her registration for the Event by contacting the Event Manager by phone or email. Transfers will not be offered after 5pm on Friday 3rd April 2009. Transfer of registration will incur an AU \$10 processing fee.

Insurance

25. WBR is affiliated with Mountain Bike Australia (MTBA). MTBA affiliation provides WBR with Public Liability insurance cover. Costs associated with the individual rider's insurance (called a Participation Day Permit) for this event are covered in the Entry Fee. This Individual Day Insurance provides individual rider protection during the event.

ACCEPTANCE OF TERMS AND CONDITIONS OF ENTRY, WAIVER RELEASE AND INDEMNIFICATION

WARNING: THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR RIGHTS

In consideration of and as a condition of acceptance of my entry in The Gelantipy Wilderness Escape (The Event):

26. I have read, understood and accept that all information contained on the Event website (www.wildernessbikeride.com.au), Entry Form, Karoonda Park Information Sheet and the Route Information Sheet, and acknowledge and agree that such information together with additional rules laid down by Wilderness Bike Ride Association Inc and additional information I will receive from WBR and Karoonda Park once my entry is accepted shall constitute the entry conditions and rules applying to the Event.
27. I hereby attest and verify that the information I have provided in my entry registration is true and correct and I understand that any false information which may be deliberately provided by me may lead to my withdrawal from the Event and render me ineligible to compete in any future WBR sanctioned events.
28. I hereby attest and verify that I am physically fit and have sufficiently trained in order to compete in the Event. I further attest and verify that I do not have a physical or intellectual impairment that may make my participation unsafe for me or others.
29. I, for myself, my heirs, my executors and administrators hereby waive and release all and any claim, right or cause for action which I or they might otherwise have for, or arising out of loss of life or injury, loss or damage or any description whatsoever which I may suffer or sustain in the course of, or consequent upon, my entry or participation in the said Event.
30. I hereby acknowledge that I have sole responsibility for my personal possessions and athletic equipment during the Event and its related activities and functions.
31. I hereby consent to receive such medical treatment that may be deemed advisable in the Event of injury, accident and/or illness during the Event.
32. I undertake to notify the Event organisers of any change in my medical status or condition, as verified in above point, likely to affect my fitness to compete in the Event should this occur following completion of my registration and prior to the days of the Event.
33. I hereby allow the free use of my name and picture in broadcasts, telecasts and press of the race as they pertain to the Event, pre and post Event.
34. I agree to comply with all the rules and directions of Event organisers, officials/marshals, and/or agents.
35. I hereby agree that in the event of a race cancellation due to storm, rain, fire, inclement weather, winds or other "Act of God" conditions, my entry fee shall be non-refundable. I also understand that WBR will make all reasonable attempts to offer an alternative where possible.
36. I hereby acknowledge this waiver, release and discharge shall operate separately in favour of all persons, contractors, corporations, associations and bodies involved or otherwise engaged in promoting or staging the Event and their servants, agents, representatives and officers and includes, but is not limited to, the various committees and members of WBR and its contractors and related bodies/suppliers, and shall operate whether or not the loss injury or damage is attributed to the act or neglect of any one or more of them.
